## Why We Like This Fund

The BlackRock Global Equity Market Neutral Fund (BDMIX) applies a quantitative, technology-driven investment process in seeking true diversification and consistent returns through market cycles. The strategy focuses on maintaining low correlations to traditional market exposures and risk factors while generating differentiated returns independent of market direction. This robust yet flexible research process relies on the deep resources in data analytics, natural language processing, and machine learning at BlackRock to help identify and convert critical fundamental and alternative data into individual alphagenerating signals that ultimately combine to form its stock-selection model. An experienced team of portfolio managers led by Raffaele Savi and Kevin Franklin, supported by 40 researchers in BlackRock's systematic active equity group, then blends dozens of signals from company fundamentals, market sentiment, and macro themes to rank the entire universe of 7000 developed market stocks. The combination of human input with machine learning techniques eventually settles on an optimal blend of long and short positions built to succeed across a wide range of market scenarios. Since a process change in 2022 that introduced more individual stock positions and greater leverage, the strategy has delivered exceptional returns in excess of 16% annualized over the three years through July 2025. The fund ranks in the top decile of category peers over the last two years and year-to-date.

### Where to Use

Given the Fund's market-neutral perspective, (BDMIX) is capable of adding significant alpha to nearly any portfolio without substantially increasing market risk. The strategy's low correlation to traditional stocks and bonds makes it a solid, diversifying supplement to balanced (60/40) accounts.
