## Why We Like This Fund

The Putnam Large Cap Value Fund (PEIYX) seeks both strong capital growth and current income. The fund defines a curated universe of U.S. large-cap value equities daily and then employs fundamental and quantitative tools to identify unique relative value opportunities. A refined stock selection process takes a multidimensional approach that analyzes three critical components of individual equities: a reasonable value proposition implying room for price appreciation, an ability and proven track record of generating strong cashflows, and a capacity to grow dividends in the future. The fund is characterized by low turnover and a long holding period which allows strategic purchases to compound their returns. Portfolio managers Darren A. Jaroch, CFA, and Lauren B. DeMore, CFA have a combined 50 years of industry experience and have successfully managed the portfolio through numerous market and macroeconomic environments. A consistent investment process and adept management team have led to best-in-class returns over multi-year periods. Absolute performance ranks in the top decile over 1-, 3-, 5- and 10-year periods. The strategy has produced impressive risk-adjusted returns, generating significantly more alpha than category peers over the benchmark across each aforementioned period, earning the fund an impressive Sharpe ratio.

## Where to Use

The Putnam Large Cap Value Fund (PEIYX) delivers potent returns on both absolute and risk-adjusted bases while ensuring risks are thoroughly managed. This fund can benefit investors seeking to diversify large-cap exposures away from overvalued, concentrated areas of the market while limiting downside risks through strong balance sheets and corporate fundamentals. The consistency of returns generated by PEIYX enables the fund to serve as a core ballast for a broader equity strategy.
